**Subject : Certificate of recognition for a school under sub-rule (4) of rule 11 of the Children's Free and Compulsory Education Rules, 2011, for the purpose of section 18 of the Children's Free and Compulsory Education Act, 2009.**

Respected Sir/Madam,

In reference to the application letter received from you and subsequent correspondence with the school, I hereby issue the admission letter for Bhai Amrik Singh Ji Khalsa Academy Manesh Block Qadian-1 for classes 1 to 8 from 01-04-2020 to 31-03-2023.

This approval will be valid only after the following terms & conditions are met:-

1. The period of approval of accreditation cannot be extended and in any case there is no commitment for accreditation/affiliation beyond class VIII.
2. The school will strictly comply with the Right of Children to Free and Compulsory Education Act, 2009 (Annexure) and the Right of Children to Free and Compulsory Education Rules, 2011 (Annexure 2).
3. Schools will provide free and compulsory education up to the level of elementary education to all students in the first class and 25 percent of the class, including all students belonging to weaker sections and disadvantaged sections in their neighbourhood. This rule will also apply to pre-primary classes.
4. The school shall make provision as per sub-section 2 of section 12 of the Act for the students referred to in paragraph no. 3 and shall provide a separate bank account for the purpose.
5. The school will not collect any compulsory fees from any parent or guardian for any action.
6. The school will not refuse admission to anyone:-
  - (a) Any child who does not have proof of birth or
  - (b) If such child is admitted during the specified or extended period (for admission):
  - (c) On the basis of religion, caste, creed, place of birth or any of these reasons
- 7: The school will ensure:
  - (a) No admitted student can be suspended or expelled in any category until his elementary education is completed.
  - (b) No student will be subjected to physical or mental punishment.
  - (c) No student shall be required to pass any board examination before completing elementary education.
  - (d) As per rule 21, every student shall be awarded a certificate after completing elementary education.
  - (e) Students with disabilities, infirmities or special needs will be admitted as per the law.

The minimum educational qualifications will be completed within 5 years of joining the job on the date of implementation of the law.


(k) Under the rules specified under section 24 and sub-section (1) of the Education Act Teachers will perform their duties.

(c) Teachers shall not involve themselves in any kind of private tuition.

8. The school will follow the timetable and curriculum distribution regulated by the competent administrative body/authority.

9. The school will admit children as per the ratio specified in Section 19 of the Act. 10 The school will comply with the criteria as per Section 19 of the Right to Education Act. If the facilities are as per the previous inspection, if any, the following:

11. No unrecognized class will be taught within or outside the premises of the school under the name of the same school.

12. The school building, and structure or playground shall be used solely and exclusively for the educational activities and skill development of the school.

13. The school is being run by a society registered under the Act (Act No. 21 of 1860) or is being run or operated by any public body for some time.

14. The school should not be run to benefit any individual class or individual coalition.

15. The school's accounts should be prepared by a certified accountant/CA and the accounts should be prepared as per the rules. Every year, a copy of the accounts will be sent to the District Education Officer (DEO) for information.

16. The recognized identity of your school is as per the above. (Please note this and in future, this identity number should be quoted while dealing with correspondence.)

17. The school shall submit all such reports and information to the District Education Officer or the Director Education Department from time to time and shall be bound to furnish such information to the State Government or the local authority as may be directed by them from time to time.



18. Deficiencies removed by the organization which are necessary for it to be registered. It should be ensured that the registration of the organization has been renewed.
